## **Independent Accountants' Report on Applying Agreed-Upon Procedures**

To the Honorable Commissioners – Nueces County Emergency Services District No. 4  
Corpus Christi, Texas

I have performed the procedures listed below, which were agreed to by Nueces County Emergency Services District No.4, solely to assist the users in evaluating the Nueces County Emergency Services District No.4 concerning selected purchases from the Texas Facilities Commission during the past four years. In addition to the purchases, review applicable laws associated with those purchases, and try to determine where the items are presently located, or if, and when they were disposed of. This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the Association of International Certified Professional Accountants. The sufficiency of these procedures is solely the responsibility of the District. Consequently, I make no representation regarding the sufficiency of these procedures described below either for the purpose for which this report has been requested or for any other purpose.

### **Scope**

The procedures engaged to be performed were as follows:

- 1) Review and examine selected purchases by Nueces County Emergency Services District No.4 from the Texas Facilities Commission for the past four years.
- 2) Review the applicable laws with those purchases.
- 3) Try to determine where the items are presently located, or if, and when they were disposed of.

### **Background**

The District has made regular purchases from the Texas Facilities Commission for several years. It was reported by individuals outside the District that two Humvees were purchased from the Texas Facilities Commission and subsequently resold to two District Commissioners. Following this, it was observed that NCESD No.4 conducted multiple transactions with the TFC over a number of years.

### **Texas Facilities Commission History**

The Texas Facilities Commission (TFC) supports the State of Texas through strategic facilities planning, asset management, design, construction, operation, maintenance, leasing of state facilities, and the sale, reallocation, or disposal of state and federal surplus property. TFC serves state agencies, legislative members/staff, and the public that utilize the state facilities owned, managed, or leased by TFC, as well as managing the renovations and construction for other state agencies.

The Texas Facilities Commission disposes of salvage and surplus personal property from Texas state agencies such as DPS, TXDOT, TCEQ, and Texas Parks & Wildlife. Examples of commonly available items include vehicles, furniture, office equipment and supplies, small electronics, and heavy equipment. The public is invited to purchase the property at our retail storefront in Austin, TX, or by bidding on an online auction.

Certain acquisitions from the TFC, over \$5,000, require a signed compliance restriction statement incorporating various federal requirements. For example, the Donee must adhere to the following federal stipulations:

- a) The Donee certifies that it is a public agency or a nonprofit institution or organization.
- b) All items of property must be put to use for their intended purposes within one year of receipt and remain in such use for at least one year from the date the property is placed in service. Certain types of property may require continued use for periods longer than one year. If the property is not timely put into, or maintained in use, the Donee must promptly notify the State agency and, at its own expense, return the property as directed.
- c) For items with a unit acquisition cost of \$5,000 or more, as well as for all passenger motor vehicles regardless of cost, the Donee agrees that such property shall be used exclusively for the purpose acquired, and for no other purpose, for a minimum of 18 months from the date the property enters service.
- d) The Donee accepts the following terms, reservations, and restrictions: From the date the property is received and throughout the duration of the above conditions, the Donee shall not sell, trade, lease, lend, bail, cannibalize, encumber, dispose of, or permanently move the property outside the State without prior approval from GSA.

### **Executive Summary**

On January 12, 2024, the NCESD No.4 Board dismissed Fire Chief Lloyd Bluntzer and EMS Director Diana Bluntzer. The District then contracted NCESD No.1 for fire and EMS supervision, appointing NCESD No.1 Fire Chief Michael Clack as NCESD No.4 Fire Chief and NCESD No. 1 Assistant Chief Stephanie Simmons as NCESD No.4 EMS Supervisor.

On March 19, 2025, the District contracted me to conduct a four-year forensic audit of selected purchases from the Texas Facilities Commission.

During a four-year span of purchases at the Texas Facilities Commission, the District acquired around 400 items with a total cost of \$61,770.00 (Pages 11-31) Eight items were selected for review; four of which are unaccounted for as of writing this report. Each original purchase exceeded \$5,000.00 and required a signed compliance restriction statement as stated on the purchase invoice. Transactions reviewed are as follows:

Three distributing systems (unaccounted for)  
One all-terrain vehicle and various containers (unaccounted for)

On May 5, 2017, the District bought a Humvee from TFC for \$3,500.00 (originally priced at \$41,061.00), which required the mandatory signed compliance restriction statement to be signed. This vehicle is out of my scope, but relevant, because Paul Swetish received it instead of the one he selected (pages 39-42).

On October 26, 2021, the District bought a four-wheel All-Terrain Vehicle for \$1,200.00 (original cost: \$12,000.00, page 18), requiring a signed compliance restriction statement, which I did not receive. Geoff Atwood had only heard about the purchase, while Paul Swetish and Michael Clack were unaware of it; the vehicle remains unaccounted for as of the date of this report.

On November 3, 2022, the District purchased from TFC three Humvees along with various other items totaling \$13,421.00 (pages 33-34). On that day, four items with an original cost greater than \$5,000.00 each were purchased, requiring signed compliance restriction statements (page 35) which were signed by Diana Bluntzer. On that date, one of the acquired Humvees was designated for cannibalization (pages 61-70), and the other two were intended to be sold to Commissioners Geoff Atwood and Paul Swetish, 10 days after the purchase, which was in violation of the signed compliance restriction statement. Geoff Atwood did receive the Humvee that he had picked out (pages 43-52), but Paul Swetish was sold the Humvee that was originally purchased on May 5, 2017, and not the Humvee purchased on November 3, 2022. Geoff Atwood paid the exact amount that the District paid to purchase his, plus \$550.00 shipping. Paul Swetish paid \$4,500.00 plus \$550.00 shipping for the Humvee he thought he picked out. However, the Humvee he received the District already had, and paid only \$3,500.00. During interviews (page 5-6) both commissioners thought this was a legitimate transaction and neither were aware of the required signed compliance restriction statements and regulations. The third Humvee, which was purchased with the intent of cannibalization (page 61-70) was not cannibalized, but was sold in a public auction on December 20, 2024, for \$7,440.00 (page 71) along with the Humvee that was supposed to be Paul Swetish's.

On April 4, 2023, the District acquired a distributing system for \$50.00 (original cost: \$6,258.00, (page 15) requiring a signed compliance restriction statement, which I did not receive. On May 17, 2023, two more distributing systems were purchased for \$210.00 total (pages 18 & 22), each originally costing \$6,258.00, and also needing a signed compliance restriction statement, which I did not receive. According to Micheal Clack, these distributing systems have not yet been accounted for.

On May 17, 2023, the District purchased a shipping and storage container for \$250.00 with an original cost of \$8,403.78 (page 81-83), which required a signed compliance restriction statement, which I did not receive, and remains unaccounted for.

On June 21, 2023, the District purchased a Cummins Diesel engine from the TFC for \$2,000.00. The original cost of the engine was \$68,024.00, which required the mandatory signed compliance restriction statement to be signed, which was signed off by Lloyd Bluntzer (page 75). According to Micheal Clack the engine was given to Jay Behrens with NJWESD#5. I interviewed Jay Behrens (page 8) and met with Micheal Clack. Clack told me that he thought the engine was still at Behrens' house. Behrens acknowledged that the engine was still at his house and wanted somebody to come pick it up. The engine was originally acquired for NJCESD No.5 fire truck, but it did not fit as required. Behrens went on to say that the reason No.4 purchased the engine for No.5 was because No.5 did not have an account with TFC, which violated asset transfer rules.

**Interview with Lloyd and Diana Bluntzer**

Multiple attempts were made through phone calls, text messages, emails, and certified letters to schedule an interview; however, no response was received.

**Interviews with Mickeal Clack and Stephanie Simmons**

Meeting with Michael Clack, Stephanie Simmons at NCESD No.1  
June 18, 2025

Michael Clack stated that it was his understanding that the Humvees were delivered and the extra money paid by Geoff and Paul was for delivery. Humvee cost was \$4,500.00; they paid \$5,050.00 each.

Stephanie said that they are missing a couple of containers. The pictures were provided by Texas Facilities Commission, so they could try and locate them.

Michael Clack stated that two Humvees were sold to CC Sales, one of those was for cannibalization and one Humvee was being cleaned up to sell to someone supposedly for \$10,000.00.

Stephanie, Noel and Clack went over the list provided by TFC.

In 2019 several 4 wheelers and ATVs were purchased. There is no sign of them. Clack said he was told that they bought them, and they were given to the Boy Scouts for projects.

Distributing systems were not around the station.

The Plasma Cutter, not at the Station

Polaris engine and diesel engine not around the station  
Refrigerator/ Freezer- don't know where it is.

Clack stated that he has sold 3 things at auction: 2 Humvees, one of which was for cannibalization, and a truck which had no value. Normally, he would have sold it by weight, but this was more transparent.

**Interview with NCESD# No.4 Board President Geoff Atwood**

Date Interviewed – June 23, 2025

**1) Who initiated the Humvee purchase transaction?**

Geoff stated that he went to Lloyd and Diana's house to sign payroll checks. There was a Humvee sitting out there. Lloyd stated that they weren't good for brush trucks. Geoff commented that if he sells it to let him know, he would like to bid on it. Lloyd told him you don't want this one, but I can get you one from Texas Facilities Commission and let NCESD No.4 buy it, and he can turn around and buy it from them. Geoff went up to the Texas Facilities Commission with Lloyd and Diana and picked out his Humvee.

**2) Who drove the Humvees back or were they delivered?**

The Humvees were delivered to Lloyd and Diana's house. Geoff went there to pick up the Humvee and gave them a check for the price of the Humvee and the delivery charge.

**3) Did you think this was a legitimate transaction?**

Thought it was legitimate.

**4) Was the Board aware of these transactions?**

Absolutely. Geoff called DW Hermann and Otis Grupe and told them what was going on.

**5) Did the Board approve the purchase of the Humvees?**

Yes, and knew they were being sold.

**6) In 2019- the District purchased several 4 wheelers and ATVs. Were you aware of these purchases?**

Geoff said he heard about it but did not know about it until about 12 months ago. He was told that they went to the Bluntzer Boy Scouts.

**7) Do you know why the District purchased them?**

No

**8) Do you know where these 4 wheelers and ATVs are today?**

No idea

**9) Did the Texas Ranger speak with you?**

No

**10) Were you aware of the purchases of Kobata Tractor, several ATVs?**

I was aware that they bought a Kubota Tractor.

**11) Is there anything else you'd like to add or say?**

Geoff asked if I was investigating the engine. " The Engine never went to the NCESD No.4." Geoff still has his Humvee.

**Interview with NCESD No.4 Treasurer Paul Swetish**

Date Interviewed – June 23, 2025

**1) Who initiated the Humvee purchase transaction?**

Lloyd talked to Paul, saying that he was going to buy one for Atwood, and would Paul be interested in one? Paul said he would but that he wanted it to be legit.

**2) Who drove the Humvees back or were they delivered?**

Paul stated that he went to San Antonio and looked at them. Paul picked it up from Lloyd's house and wrote a check for the Humvee and transportation cost.

**3) Did you think this was a legitimate transaction?**

Yes. They worked it out dollar for dollar, and transportation fee.

**4) Was the Board aware of these transactions?**

Yes. Geoff called D W Hermann and Otis Grupe and told them what was going on.

**5) Did the Board approve the purchase of the Humvees?**

Yes. Knowing that the Humvees were being sold.

**6) In 2019 the District purchased several 4 wheelers and ATVs. Were you aware of these purchases?**

Doesn't know about them.

**7) Did the Texas Ranger speak with you?**

No

**8) Is there anything else you would like to add or say?**

At the time of the transaction, he didn't know about the rules of the TFC concerning retaining & placing in service items bought from them. If I had it to do over again, I would go to Iron Planet and get a Humvee, for about the same price.

Paul still has his Humvee.

**Interviews with NCESD No.4 Vice Treasurer Otis Grupe**

Date Interviewed – July 9, 2025

**1) Did you sign the checks to the Texas Facilities Commission?**

Yes

**2) Were you aware of what was being purchased?**

Not until I saw the invoice for the check and then saw the remittance for them.

**3) Did you think this was legal?**

I wasn't sure it was right. I wasn't going to sign the check when Diana came by, so she said she was going to DW Hermann's to sign it. I called DW Hermann and asked what was happening. DW Hermann told Otis that he had signed the check, so Otis decided to sign. Otis figured that it was ok because Geoff and Paul had been on the Board for some time. and Lloyd and Diana were head of the Fire Dept, and EMS for a number of years.

**4) Were you aware of the rules of the Texas Facilities Commission?**

Only about the 18-month deal.

**5) In 2019 the District purchased several 4 wheelers and ATVs. Were you aware of these purchases?**

No sir, no sir and where are they? I have never seen them, only on paper. I have been on the Board since 12-12-2012 and never saw any of these. I saw the list of all the items bought. I questioned Diana more than once about where this stuff is going. We had an old Humvee there for a while that was finally sold. You know you trust people that have been there for a while. Trust goes a long way for me.

**Interview with NJWCESD No.5 Board President Jay Behrens**

Date Interviewed – June 23, 2025

**1) Did you purchase an engine from NCESD No.4?**

No. I have the engine in storage.

**2) Who initiated the engine purchase transaction?**

It came up in conversation with Lloyd, that NJWESD No.5 needed an engine for a truck. Jay said he does not have an account with the Texas Facilities Commission.

**3) Who delivered the engine to you?**

Lloyd either delivered it, or they (Lloyd and Jay) went to pick it up from Bluntzer.

**4) Did you pay for the engine?**

No

**5) Was this engine intended for NJWCESD No.5 or personal use?**

NJWESD No.5 fire truck but was not right fit for the truck.

**6) Where is the engine today?**

I still have it. It is still on the pallet and tarped. Jay told Clack that he had it.

**Interview with Texas Ranger Dwayne Hinojosa**

**1) Are you aware of the situation at NCESD No.4 concerning TFC purchases?**

Inquiries had come into the office concerning NCESD No.4. Nothing progressed other than inquiries.

**2) Do you have anything that will help me with my report?**

No

**3) Did you speak with Lloyd or Diana Bluntzer?**

No

**4) Did you speak with Geoff Atwood, Paul Swetish, or Jay Behrens?**

No

Observations – The District has made numerous purchases at the Texas Facilities Commission over several years, with limited oversight. In the four years I reviewed, about 400 purchases were made, many of which cannot be located to date. Purchases requiring signed compliance restriction statements often did not comply with stated usage as agreed to when purchased and signed by District management employees (Diana Bluntzer, EMS Director and Lloyd Bluntzer, Fire Chief); for instance, ATVs and four-wheelers were acquired without clear records of their intended purpose or whereabouts. Three Humvees were bought on November 3, 2022, two were to be resold to Commissioners, and one was supposed to be cannibalized. Geoff Atwood received one of the Humvees, 10 days after it was purchased on November 3, 2022, which violated the signed compliance restriction statement, which was signed by District management employees. The other two Humvees were held for over 18 months and sold at a public auction. Paul Swetish received the Humvee purchased on May 5, 2017, rather than the one he picked out. Geoff Atwood and Paul Swetish both have their Humvees as of today. An engine purchased for NJWCESD No. 5 was bought under NCESD No. 4's name, violating asset transfer rules. When the District contracted NCESD No. 1, efforts were made to locate items previously purchased, assisted by TFC photos. These included distributing systems, an ATV, containers, and a refrigerator freezer. As of the writing of this report, none of these purchases have been located.

I was not engaged to, and did not perform, an examination, the objective of which would be the expression of an opinion on management's concerns. Accordingly, I do not express such an opinion. Had I performed additional procedures, other matters might have come to my attention that would have been reported to you.

This report is intended solely for the use of Nueces County Emergency Services District No. 4, and its designees and should not be used by those who have not agreed to the procedures and taken responsibility for the sufficiency of the procedures for their purposes. Other parties to whom the report may be provided should be advised that the procedures were performed only for the purposes of the specified parties.
